It is widely recognized the current child welfare and criminal justice systems are not able to respond to the needs of Indigenous people. A major obstacle to the health of Canadian Indigenous communities and people is the lack of culturally relevant and Indigenous-led resources to help navigate the justice system, child welfare and other structures in which they must operate.

This results in poorer outcomes for these individuals and the wider community, making Indigenous-led and culturally relevant solutions urgently required.

INDIGENOUS KNOWLEDGE, CULTURAL AND JUSTICE PRACTICES

Indigenous cultural practices can improve the lives of all Canadians. At our core, we integrate Indigenous knowledge, cultural practices, and justice practices into Canadian communities and systems.

CHILD AND FAMILY SERVICES

The Indigenous community knows best how to help a community member in crisis, and ALS is bringing Indigenous practices and support systems to child and family services.

From dispute resolution and family support services, to our work tackling Fetal Alcohol Syndrome, ALS works with communities and families to push for the best outcomes for Indigenous children and families.

THOUGHT LEADERSHIP, PARTNERSHIPS, AND COMMUNITY EDUCATION

ALS is a national thought leader in Indigenous issues, educating Indigenous & non-Indigenous people about the issues facing these communities in Canada's public systems. We also run programming which shares Indigenous knowledge and ceremonies for both Indigenous and non-Indigenous peoples.

JUSTICE AND ADVOCACY

ALS is dedicated to changing the legal landscape to support Indigenous communities. We provide Indigenous, culturally based programming that helps people who are involved with the criminal justice system find their out of that system. We provide programs that assist Indigenous through the court process and write reports to the courts to assist in sentencing. We also tackle systemic issues by working on inquests and national Supreme Court challenges which advance the rights of Indigenous Canadians in the legal system.
